Sandy Point Heights has recently experienced two major water breaks. The first main break on January 3, 2020 was located on Pender Drive. Our staff was alerted by members of low water pressure, after quick response and investigation, it was determined that a tree's roots uprooted our water main and took out PSE's power lines. The site was classified as unsafe until PSE responded and repaired their power lines. As soon as the site became safe, our water staff was able to assess the situation and began working to successfully repair the water main. The second main break occurred on January 27, 2020. The main break was located, assessed, and immediately began repair. It was determined the break occurred due to ground shifting. We greatly appreciate everyone's patience through these trying breaks.
