WATER SERVICE FEES

The Sandy Point Improvement Company provides water service to property owners in the Sandy Point area. The following water service fees and usage charges are applicable April 1, 2018 and are subject to change.

FEES and CHARGES:

Water is charged with a Base Fee and a Usage Fee. The **Base Fee** is \$35.00 per month for each lot regardless of water use (\$420.00 annually). **Usage Fees** are variable depending on amount of water used *per cubic foot* per the following table. Water fees are billed every two months on the 15th, subject to change. A finance charge of \$10.00 (or 1% of the outstanding balance) per month will be assessed on the 20th of each month on unpaid invoices.

<u>Limited Use water hook-ups:</u> ATTENTION ALL VACANT METERED PROPERTIES

These allow for 12.2 gallons (1.6309 CF) of water use per day. The first 596 CF of water used annually is billed according to the above published tier rates. Any water used above 596 CF in an annual billing period (December 15th to December 15th) is billed at the highest tier rate.

Reading your Water Bill: On the water statement, "**Cur Rd**" indicates your current meter reading in *cubic feet*. One cubic foot equals 7.48 gallons. "**Use**" is the amount of water used during that two month billing cycle (i.e. 23000 means 23,000 *cubic feet* of water was used during the previous two month billing cycle).
